### **Distinguished Delegates' Profiles:**

#### Mr. Abu Farah Md. Nasser, Chief Guest



Mr. Abu Farah Md. Nasser has been Deputy Governor of Bangladesh Bank since March 2021. He started his career as Central Banker at Bangladesh Bank in October 1988. With over 32 years of experience in different positions in Bangladesh Bank, he supervised the activities of the Banking Regulation and Policy Department, Department of Off-site Supervision, Department of Banking Inspection, Agricultural Credit Department, SME & Special Programmes Department, etc. He has a wide range of experience in serving as the Member of the Executive Committee at Islamic Financial Services Board (IFSB) in Malaysia, Member of Technical Committee at IFSB in Malaysia, Director of the Karmasangsthan Bank, Chair of the Advisory Committee in formulating Guidelines on Green Bond Taxonomy, and many more. He also served in Microcredit Regulatory Authority (MRA) as a Director for three years on Deputation. He held many important roles, such as, the Advisor of the Financial Stability Report Preparation Committee, Coordinator of the Guidelines on Internal Credit Risk Rating System for Banks, Chief Coordinator of the Policy Guidelines for providing financial support to export-oriented industries, local industries and Traded business affected by COVID-19, etc.

Mr. Nasser obtained his Master's & Bachelor's degrees in Accounting from the University of Dhaka. He is the first-ever National Integrity Award winner of Bangladesh Bank in 2019. His primary areas of interest are prudential regulation, banking risk management, corporate governance, macroeconomic & financial stability, sustainable Financing, and green bond taxonomy, etc.

In his illustrious career, Mr. Nasser visited many countries to attend various courses, seminars, and conferences organized by international institutions; notably, World Bank, IMF, Federal Reserve System, Asian Development Bank, AFI, APRACA and The Islamic Financial Services Board.

#### Dr. Mridul Kumar Saggar, Keynote Speaker



Dr. Mridul Kumar Saggar has been a central banker for three decades. He has varied experience in various fields related to macroeconomics, monetary policy, financial markets, international financial architecture, global financial regulatory reforms and national income accounting. He is currently the Executive Director at the Reserve Bank of India overseeing the economics and policy research in the central bank. He is also the member of its Monetary Policy Committee (MPC) that sets the central bank's policy rate and the Financial Markets Committee (FMC) that looks after financial market operations for monetary policy implementation.

In past, he had also served as Head of the International Department of the Reserve Bank with responsibilities that included international financial architecture and global financial regulatory reform issues besides central bank swap arrangements. He also Chaired the Working Group on SAARFINANCE database during 2018-20, operationalizing it and then steering it to new improved levels.

Dr. Mridul has represented India in senior capacity at various international bodies like the Bank for International Settlements (BIS), Financial Stability Board (FSB), International Monetary Fund (IMF), OECD, G20, BRICS and SAARC. He has represented India at the G20 Finance Deputies and on international committees such as International Financial Architecture (IFA), Framework Working Group (FWG), Infrastructure Working Group (IWG) and OECD Advisory Task Force on the Codes on Capital Account Liberalization (ATFC). He has also served on various governmental committees and Expert Groups and has been on the Advisory Committee of the International Institute of Banking and Finance (IIBF). Currently, he is on the Executive Committee of the Indian Association of Research in National Income and Wealth (IARNIW).

During 2008-10, he had a stint as Chief Economist of Kotak, India's largest I-bank and served institutional portfolio investors all over the globe. He also participated in several debates on financial news channels. He holds a doctoral degree from Indira Gandhi Institute of Development Research, Mumbai and has been a fellow at the Princeton University, New Jersey, USA. He is a distinguished researcher with over 50 published articles in magazines and professional referred national and international journals. He has delivered guest lectures at several central banks and academic institutions in various parts of the world.

#### Mr. A.K.M. Fazlul Haque Mia, Special Guest



Mr. A.K.M. Fazlul Haque Mia started his professional career as an Assistant Director on 1 April in 1989 in Statistics Department of Bangladesh Bank. He is currently holding the post of Executive Director (Statistics) since 28 March, 2019. He became Executive Director (Specialized) on 3 October, 2016. He has completed B.Sc. (Hon's) and M.Sc. in Statistics from Jahangirnagar University.
