## Security Council Al-Qaida Sanctions Committee Deletes Abdelhadi Ben Debka from Its Sanctions List

## **Decision Taken Following Review of De-listing**

## **Request Submitted Through Office of the Ombudsperson**

On 19 December 2013, the Security Council Committee pursuant to resolutions 1267 (1999) and 1989 (2011) concerning Al-Qaida and associated individuals and entities **removed** the name of the individual below from the Al-Qaida Sanctions List after concluding its consideration of a de-listing request submitted through the Office of the Ombudsperson established pursuant to Security Council resolution 1904 (2009), and after considering the Comprehensive Report of the Ombudsperson on this de-listing request.

Therefore, the assets freeze, travel ban and arms embargo set out in paragraph 1 of Security Council resolution 2083 (2012) no longer apply to the name set out below.
