The Government of India has decided for promotion of payment through cards and digital means for payment of government receipt including tax revenue. Accordingly, the following decisions are conveyed for compliance :

- All authorized banks must enable payment of taxes through Debit 1. Card by 31st January 2017.
- No Merchant Discount Rates (MDR) shall be charged from the tax 2. payer on account of payment of direct tax collection upto Rs.1 Lakh as per CGA order No.F.No.1(1)/2006/ECS/TA/670 dated 15.12.2016 (copy enclosed).
  - All authorized banks for direct tax collection shall submit the claims. of applicable Merchant Discount Rates (MDR) charges to Reserve Bank of India (RBI) periodically alongwith a certificate regarding non receipt of MDR charges from the tax payer on account of tax

amount upto Rs.1 Lakh as per CGA order No.F.No.1(1)/2 06/ ECS/TA/669 dated 14.12.2016 (copy enclosed).
